Grey Eagle continues to look at utility project

Council makes no decision to move forward as potential project costs have yet to be determined

The Grey Eagle City Council is continuing to examine whether the city should go ahead with updating the city's existing water and sewer lines.

The city has already televised the 50-year-old lines and is now in the position of determining whether or not they should move forward with a project to replace the existing lines and how they can be paid for.

Jeff Scholten from the Rural Development office of Alexandria and representatives from the engineering firm of Widsch, Smith & Nolting were on hand to provide some information for the council to consider regarding funding for a potential project.

They explained that there is funding available for projects like this from the Rural Development Fund, Small Cities Development Program, and

the Waste Water Infrastructure Fund.

The council did not make a decision on whether or not to move forward with the project as final costs for a potential project have yet to be determined.

Water/Waste Water

It was reported to the council that a resident had flushed a pair of long john's down the toilet, which had become lodged and caused damage to one of the system's pumps. The city staff is currently seeking replacement parts. If parts or a replacement pump can't be found, the city will need to revamp its lift station for a new pump.
